THIS AMENDMENT OF MASTER DEED FOR WINDMILL HARBOUR MARINA HORIZONTAL PROPERTY REGIME ("Amendment") is made effective October 1, 2008 by the WINDMILL HARBOUR MARINA ASSOCIATION, INC., a South Carolina non-profit corporation ("Association").

WHEREAS, on February 11, 1995, Windmill Harbour Company established the Windmill Harbour Marina Horizontal Property Regime by Master Deed recorded in the Beaufort County RMC Office on February 14, 1985 in Deed Book 413 at Page 547, which Master Deed was amended in Deed Book 518 at Page 1931, Deed Book 520 at Page 699, Deed Book 522 at Page 519, and Deed Book 560 at Page 208 ("Master Deed"); and

WHEREAS, the Master Deed established the Association and set forth bylaws for the operation and administration of the Association, said bylaw amended in 1996 by Amendment of Windmill Harbour Marina Association, Inc. Bylaws recorded in the Beaufort County Register of Deeds Office in Official Record Book 892 at Page 924 and Official Record Book 911 at Page 1718 ("Bylaws"); and

WHEREAS, Article XI, Section 1 of the Association's Bylaws provides that at least sixty-seven percent (67%) of the votes of the Association are required to, among other things, alter the boundaries of any Unit, as that term is defined in the Master Deed; and

WHEREAS, the Association conducted a referendum among its members seeking approval of the below Amendment to the Master Deed; and

WHEREAS, on September 30, 2008, the Association had received written consent of over sixty-seven percent (67%) of the votes of the Association approving such an amendment to the Master Deed as more particularly set forth below, specifically, seventy-two percent (72 %) of the votes of the Association were in favor of the Amendment set forth below.

WHEREAS, the undersigned President of the Association does hereby execute this Amendment effective October 1, 2008 to give record notice of the Amendment to the Association's Master Deed set forth below.

NOW, THEREFORE, the Association hereby amends this Master Deed in the following manner:

1. Exhibit "C" "Description of Units" to the Fourth Expansion Amendment to Master Deed establishing Windmill Harbour Marina Horizontal Property Regime ("Phase V") recorded in the Beaufort County Register of Deeds Office in Official Record Book 560 at Page 208 is hereby amended by deleting the following text:

Units M-1 and M-2 are 5.5' in width, 45' in length and are constructed of wood. These units are parallel to the bulkhead of the harbor access zone and are connected by a wooden ramp.

and replacing the deleted text with the following text:

Units M-1 and M-2 are 16' in width, 45' in length and project into the Marina Basin from the bulkhead of the Harbour Access Zone. Said areas are reserved for the exclusive use of the Owner(s) of Units M-1 and M-2. Access to Units M-1 and M-2 is from the Harbour Access Zone and each Unit contains a tower/water supply located adjacent to said Unit on the Harbor Access Zone. The Units include the right to encroach on the surface of the bulkhead of the Harbour Access Zone for the installation and maintenance of up to two (2) ladders for each Unit to access watercraft within the Unit(s). The Units include easement rights throughout the six foot (6') area between the Units. Three feet (3') of such easement area shall be allocated to each of Unit M-1 and M-2. Said easement area shall be reserved only for the encroachment of watercraft from Unit M-1 and M-2. No permanent installations shall be allowed in the easement area between the Units.

- 2. The above Amendment does not affect the statutory value or percentage value of Units M-1 or M-2, or any other Unit in the Regime.
- 3. Attached as Exhibit "A" to this Amendment is an engineer's drawings of the Units M-1 and M-2 and attached as Exhibit "A-1" is an Engineer's Certificate certifying that Units M-1 and M-2 are constructed substantially in compliance with the engineering diagrams attached hereto as Exhibit "A".
- 4. Attached hereto is the consent of the Declarant, as defined in the Master Deed, to this Amendment.


