# SECOND AMENDMENT TO THE DECLARATION OF COVENANTS, RESTRICTIONS AND PROVISIONS FOR THE SINGLE-FAMILY DETACHED LOTS AND THE TOWNHOME LOTS OF ALLENWOOD

WHEREAS, the Declarant now desires to annex additional property located in Phases II, III, IV and V, Allenwood Subdivision, as more particularly described in Exhibit "A" (the "Additional Property") and to make certain other amendments; and

WHEREAS, Village Square Development Company, LLC, a South Carolina limited liability company, and Hilton Head Homes, LLC, a South Carolina limited liability company, are

the owners of portions of the Additional Property, and desire to join the Declarant in subjecting said property to the Declaration.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS THAT B C & W, LLC, as Declarant, Village Square Development Company, LLC and Hilton Head Homes, LLC, as owners of portions of the Additional Property, and the Allenwood Homeowners Association, Inc., as required by Article II, Section 2.2(a) of the Covenants, hereby resolve and declare as follows:

- 1. All of the said Additional Property, as more particularly described in Exhibit "A", shall hereafter be owned, held, used, enjoyed and conveyed subject to the terms of the Covenants, which shall run with the title to all said Additional Property and shall be binding upon all Persons having any right, title or interest in such Additional Property, their heirs, successors, successor-in-title and assigns.
- 2. Exhibits "B" and "C" to the Covenants are amended and replaced in their entirety with Exhibits "B" and "C" hereto.
- 3. ARTICLE IX, Section 9.4, is amended to read as follows:
  - 9.4 <u>Garbage Removal.</u> No containers for garbage, trash or other refuse, clothes lines and all other maintenance and service facilities shall be erected, altered, placed or permitted to remain on any Lot except on the interior of the main Structure or accessory building, or behind a fence or shrubbery sufficient to hide all such containers or facilities from view. No incinerators for garbage, trash or other refuse shall be placed, used or permitted to remain on any Lot, and the maintenance of accumulated waste plant materials is prohibited except as part of an established compost pile fenced or screened from view.
- 4. Any capitalized terms contained herein and not specifically defined herein shall have the meanings set forth in the Covenants.
- 5. Except as specifically amended and modified by this Amendment, the Covenants shall continue in full force and effect in accordance with its terms
